Membership Information

Members of the Electrical Association of Rochester may be:

Organizational

Corporations, Partnerships, Sole-Proprietors primarily involved in the manufacturing, distribution, installation or sales of electrical products or services including Voice/Data/Video. Membership includes all employees of the organization in the greater Rochester area. Each Organizational member's representative shall have one vote in all matters brought before the membership. This category shall include contractors, installers, distributors, manufacturers, manufacturers representatives, utilities, energy service companies and others that meet these requirements.

Individual

Persons who are not covered by company membership. Individual members do not have voting rights, may not hold office, do not represent any organization and may not use the association as a marketing tool.

Affiliate

Companies or organizations not involved in the manufacturing, distribution, installation or sales of electrical products or services who wish to support the association. Membership includes all employees of the organization in the greater Rochester area. Each Affiliate member's representative shall have one vote in all matters brought before the membership. This category shall include: architectural, design and engineering firms; accounting and legal firms; non-profits, governmental agencies; educational institutions; and financial and insurance organizations.

Note: If a Member is organizational or affiliate, it shall designate, by written notice to the Executive Director of the Association, a representative to exercise its vote and otherwise act on its behalf. Such designation may be changed at any time by written note to the Executive Director of the Association
